This is reference to the NEP-UGCF-2022 Examination to held during February / March-2023.

The following guidelines have to be cared for NEP UGC practical examination wherever applicable.

- While maintaining the continuous evaluation policy, 50% of the evaluation of practical related to DSC (Discipline Specific Core), DSE (Discipline Specific Elective) and GE (General Elective) is to be done through End Semester Examination with one internal and one external examiner.
- The internal and external examiner will be appointed by the respective Committee of Courses of the different Departments of the University.
- 3. 25% Marks of the evaluation should be distributed on Continuous Assessment of the semester.
- The remaining 25% of the marks the evaluation should be distributed on the basis of viva-voce during the End Semester Term Practical Exam.
- The minimum number of experiments / programs / exercises to be performed in the practical
 of a paper will be decided by the respective Committee of Courses of the Department to
 maintain uniformity and minimum standard.
- The number of experiments / programs / exercises by each student must be recorded on the award list by the internal examiner/s.

NOTIFICATION

This is in reference to the Choice Based Credit System (CBCS) examinations to be held during November/December - 2016. The following subjects have to be cared for CBCS Practical examination, wherever applicable:-

"While maintaining the continuous evaluation policy, 50% of the evaluation for practicals (related to CORE and BLECTIVE papers) be done through an end-Semester examination with at least one external examiner. The external examiner/s will be appointed by the respective Committee of Courses of the University Departments. The remaining 50% marks of the evaluation should be distributed on the basis of number of experiments carried out by the student during that semester. Minimum number of experiments to be performed in the practicals of a paper will be decided by the respective Committee of Courses of the Department to maintain uniformity and basic standards. The number of experiments performed by each student must be recorded on the Award list by the internal examiner. The evaluation of practicals related to the Skill Enhancement courses will be carried out by the internal examiner/s only."
